**ORDER PROVIDING 25 MINOR CLAIMANTS THIRTY MORE
DAYS TO SUBMIT MISSING FORMS OR BE DISQUALIFIED**

On August 26, 2009, the Claims Administrator for the Tolbert Qualified Settlement Fund (the "Fund"), advised the Court that (i) 6 minor claimants (born on or after June 30, 1985) who have now reached 19 have not submitted an Advance Payment Form within 30 days after being requested in writing to do so; and (ii) 19 minor claimants who have now reached 19 have not provided other missing forms within 14 days after being requested in writing to do so.

The Claims Administrator recommends that these 25 claimants (the "Document Deficient Minors") be given 30 additional days to complete their forms or be disqualified from receiving additional payments from the Fund.

The Court, having reviewed the Claims Administrator's Report and considered all other matters and things that are appropriate, it is hereby ORDERED, ADJUDGED and DECREED as follows:

- (1) Each of the 25 Document Deficient Minors shall be provided a written request by the Claims Administrator, mailed to the claimants at his or her last known address and providing the missing forms, within 10 days from the date of entry of this Order and instructing the claimant to complete the missing form or forms within 30 days after the notice letter is mailed to the claimant by the Claims Administrator.
- (2) The Document Deficient Minors shall also be notified of this last opportunity to receive payments by publication of notice in the Anniston Star on a Sunday as soon as practicable using the form of notice in Exhibit A, and by posting this Order on the Tolbert QSF Website home page, or www.tolbertqsf.com.
- (3) Any Document Deficient Minor who does not timely provide the missing form or forms to the Claims Administrator shall be forever barred from receiving further personal injury payments from this case, absent a showing of good cause. Notwithstanding the foregoing, Document Deficient Minors who fail to submit the form or forms in time shall continue to be barred from filing any additional claims against the Defendants or the Released Parties with respect to the matters that are settled herein.

As to the foregoing it is SO ORDERED this the 18th day of September, 2009.
